- (iv) That the school shall comply with the provisions of section 10(1) read with Rule 125 of DSEAR, 1973.

- (vii) That the school shall comply with the orders/guidelines of DoE dated 07/11/2017 and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
- (viii) That the school shall appoint the second Special Educator within 02 (two months) of issuance of letter for extension of provisional recognition.
- (ix) That the school shall comply the section 17(3) of DSEA, 1973.
- (x) That the school shall submit the latest water test report from DJB within 02 months from the issuance of letter for extension of provisional recognition.
- (xi) That the school shall furnished the police verification of the staff of the school within two months of issuance of letter for extension of provisional recognition.
- (xii) That the school appoints requisite number of regular PGTs/TGTs subject specific i.e. Science/Computer Science and others.
- (xiii) That the physical inspection report of the school shall be conducted by the DDE District within 06 months of opening of the school.
- (xiv) That the school shall get the permission to run nursery class from the competent authority before the start of next academic session i.e. 2022-23.
